Membership dues to GACS are computed at **\$18.00** per student and professional employee. AACS dues are **\$3.00** per professional employee (administrators and teachers) and students. Dues are also required for daycare and extended care students. Dues must be paid on home school/satellite students which are in any way affiliated with the school, since these students are eligible for GACS programs such as standardized achievement testing, fine arts, athletics, and other benefits. Dues for day care centers are based on an average enrollment for the year. GACS has a letter to parents, that you may request, which provides information on the value of GACS membership.

Dues for **FIRST YEAR** membership (*schools that have not been affiliated with GACS for the last five years*) is reduced 25%. If you have any questions about this please contact the GACS Office at 706-549-2190.

If dues are not paid by September 30, the school is dropped from membership.
